CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 7:30 P.M.

ROLL CALL:

MINUTES:

A motion was made by Swarm and seconded by Hobler approving the minutes from the July 1, 2013 as presented. Motion carried.

REGULAR BILLS:

A motion was made by Hobler and seconded by Stunkel approving the regular bills as presented. Motion carried.

SPECIAL COUNCIL BILLS:

A motion was made by Hobler and seconded by Stunkel approving the Special Bills as presented: Civic Systems in the amount of \$3,164.00 for semi-annual fees for 2013; SCIRP & DC in the amount of \$1,850.00 for expenses incurred in assisting the City in administering a Flexible Opportunity grant from DCEO to downtown project; Nutoys Leisure Products in the amount of \$16,358.00 for benches & trash cans for Vandalia Streetscape; Kinney Contractors,
