MINUTES: A motion was made by Swarm and

seconded by N. Clark approving the

minutes from the August 19, 2013 meeting, with a correction as noted. Motion

carried.

REGULAR BILLS: A motion was made by Stunkel and

seconded by Beesley approving the

regular bills as presented. Motion carried.

SPECIAL BILLS: A motion was made by N. Clark and

seconded by Stunkel to approve all special

bills as submitted:

Timmermann & Co. in the amount of \$28,000.00 for the annual audit; Direct Energy in the amount of \$14,382.77 for electric service; Ameren Illinois for \$2,569.59 for electric service; Hurst Rosche Engineers, Inc. in the amount of \$2,500.00 for engineering service on annual dam inspection; and Brenntag Mid South for \$10,675.95 for chemicals for Water & Sewer Plants. Motion carried.

ANNUAL AUDIT PRESENTED:

Dale Timmermann and Trisha Elam of Timmermann & Co. presented and explained the City's annual audit for 2012-2013. They reported that overall, the City's financial condition is improved, but warned that there are some large expenditures coming up in the future.

Dale Timmermann pointed out that the water flow accounted for during 2013 was 92.64% as compared to 61.5% in 1981. This was quite an improvement.

Trisha Elam presented the "Calculation Of Annual Adjustment In Water And Sewer Rates" for the year ending 04/30/2013. They recommended the City increase the water rates 2.10% and 3.51% for the sewer rates. Timmermann recommended the Council should allow this raise in rates to take effect. No action was taken at this time.

N. Clark moved and Stunkel seconded to accept the annual audit as presented. Motion carried.

2013 ANNUAL LAKE DAM INSPECTION:

Hobler made a motion to accept the 2013 Annual Lake Dam Inspection as presented by Hurst-Rosche Engineers, Inc. The cost for their services was \$2,500.00. Lester seconded the motion. Motion carried.

SET TRICK-OR-TREAT NIGHT IN VANDALIA:

Beesley moved and Crawford seconded to set the annual Trick-Or-Treat Night for Saturday, October 26th from 6:00-8:00 p.m. Motion carried.

APPROVAL FOR PURCHASE OF GAS GENERATOR FOR RANDOLPH STREET PUMP STATION:

Beesley made a motion to approve the quote on a 2007 Cummins 125 kW standby generator for use at the Randolph Street Pump Station for \$23,500.00 plus \$1,200.00 shipping. The City will also have the cost of pouring a concrete pad to place it on. Stunkel seconded. Motion carried.

<u>APPROVAL TO PURCHASE</u> VALVE FOR WATER PLANT:

A motion was made by Beesley and seconded by B.J. Clark to accept the low bid of of \$647.90 from HD Supply Waterworks, Ltd. to replace a broken water valve at the Water Treatment Plant. Motion carried.

AUTHORIZATION TO ADVERTISE FOR BIDS FOR 79 FOOT AERIAL LADDER TRUCK FOR FIRE DEPT: N. Clark made a motion to authorize Fire Chief Ed Taylor to advertise for bids for a 79 foot Aerial Ladder Fire Apparatus for the Fire Department. The bids will then come before the Council for approval.

Stunkel seconded the motion. Motion carried.

APPROVAL TO SEEK BIDS FOR SIDEWALK REPLACE-MENTS:

Public Works Director John Moyer presented a list of sites where sidewalk replacements are needed. He asked the Council for approval to seek bids for this project. N. Clark moved and Lester seconded. Motion carried.

REQUEST FOR LIQUOR LICENSE FOR STARMAX CINEMA:

Rick Cripe requested a liquor license for his new multi-plex theatre being built at 215 Mattes Ave. The Council will get some public input and will take a formal vote at the next Council Meeting.

TIF ADVISORY COMMITTEE MEETING MINUTES OF AUGUST 29, 2013:

N. Clark moved and Stunkel seconded the motion approving the August 29, 2013 TIF Advisory Meeting Minutes. Motion carried.

Hobler announced that the volume of camping at the Lake has dropped.

The recent Motorcycle Show was a success with 70 plus motorcycles, and donated their proceeds to the Shriners.

Mayor Gottman mentioned that Richard Dement of Mt. Vernon I-64 Auto Auction purchased the five vehicles sold at public auction on August 10, 2013, for a total of \$2,617.77.

Mayor Gottman wished to publicly thank the Fayette County Board for their donation of \$50,000.00 toward the West Interchange Water Project. Their partnership with the City is appreciated. In honor of "Labor Day", Neil Clark wished to go on record as thanking the City employees and appreciating them for their service to the community.

Tiger Patrick of "Cross Over America" came through Vandalia recently. Their group is honoring all who have fallen since 9/11 while fighting for our freedom.
