<u>CALL TO ORDER:</u> Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 7:30 P.M.

**PLEDGE OF ALLEGIANCE:** The Pledge of Allegiance to the American Flag was given by all present.

- MINUTES: A motion was made by Swarm and seconded by Hobler approving the minutes from the September 14, 2015 as presented. Motion carried.
- **REGULAR BILLS:** A motion was made by B. John Clark and seconded by Stunkel approving the regular bills as submitted. Motion carried.

RESOLUTION #2015-9-21-A: AGREEMENT FOR GRANT WRITING SERVICES BETWEEN THE CITY OF VANDALIA & SOUTH CENTRAL IL REGIONAL PLANNING & DEVELOPMENT COMMISSION A motion was made Swarm and seconded by Crawford approving Resolution #2015-9-21-A, Approving An Agreement For Grant Writing Services Between The City of Vandalia and South Central Illinois Regional Planning & Development Commission.

The SCIRPDC will assist the city with the preparation of applications for U.S. Department of Agriculture Rural Development grants for the police department as well as the fire department.

Chief Ray said the police department will seek a grant that will help pay for a new squad car.

The fire department will seek a grant that will help pay for new air tanks.

Chief Ray said the grant is still available until next spring and may require matching funds from the city.

ORDINANCE #2015-9-21-B: AMENDING CITY OF VANDALIA MUNICIPAL CODE AT CHAPTER 15, "BUILDINGS AND CONSTRUCTION" AT SECTION 15.25.020 WATER SYSTEM DISCONNECTION PAYMENT REQUIRED A motion was made by Lester and seconded by Stunkel, adopting Ordinance #2015-9-21-B, Amending the City of Vandalia Municipal Code At Chapter 15, *Buildings And Construction* At Section 15.25.020 Water System Disconnection Payment Required.

Only the Public Works Department of the City of Vandalia shall disconnect a private water system from the Public Water System. A request for disconnection shall be made in writing to the Building and Zoning Department of the City of Vandalia. Upon receipt of said request the Public Works Dept. of the City of Vandalia shall perform the disconnection at *no charge to the property owner*.

Roll Call Vote: Swarm, yea; Hobler, nay; Stunkel, yea; Hubler, yea; Rebbe, yea; Crawford, yea; Lester, yea; B. John Clark, yea. Motion carried.

A motion was made by Swarm and seconded by B. John Clark giving Mayor Gottman authorization to sign a "Waiver of Liability" for property at 127 West Madison to remove a fallen tree.

The city is trying to help the family owning the property clean it up.

The council was in favor of doing so. Motion carried.

MAYOR'S REPORT: Mayor Gottman reported that Razmus Demolition Service is hoping to wrap up their work shortly. They are getting ready to back fill and then seed and straw the area.

> Mayor Gottman said they did have to perform some asbestos removal about \$12,000 of asbestos.

> Mayor Gottman said, the next thing to look at is what we are going to do to help the building owners with the walls of their buildings that were adjacent to the demolished buildings.

> Mayor Gottman reported that The Turning Leaf opened Saturday, September 19<sup>th</sup> at 513 W. Gallatin St.

> The Flower Sack Bakery is now opened at 529 W. Orchard St.
