CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 7:30 P.M.

A moment of silence was observed for Dennis Helm who passed away last week. He & his wife Joanna were former owners of Words Wicks & Wood in downtown Vandalia.

MINUTES:

A motion was made by Stunkel and seconded by Barker approving the minutes from the August 6, 2018 meeting as presented. Motion carried.

REGULAR BILLS:

Mayor Gottman reported that Capitol View Restaurant have awarded the bid to Andy Craig Excavation to have the building torn down and have the rubbish removed.

CLERK GIVES REPORT ON THE GO BOND OBLIGATION FOR RIVER INTAKE PROJECT:

Bowen reported someone had questioned when the GO Obligation Bond for the river intake will be paid off and that date is December 2027. The amount still owed is \$2,020,953.18.
