MAYOR'S REPORTS:

Mayor Gottman says that since we were just approved of the Bicentennial Board of Directors, they have had a group meet for the first time several weeks ago, which was Mayor Gottman, Mike Radliff, LaTisha Paslay, Todd Stapleton and a Representative from the First National Bank, John Goldsmith. They talked about the 200th anniversary. And they had another meeting to talk about the by-laws because we are going to fall under the Old Capital Foundation for being non for profit to raise money to pay for the event.

Mayor Gottman also said that David Zimmerman did a great job on the video about the Statehouse for the Bicentennial for the State of Illinois.

Mayor Gottman encourages everyone to look at the City Parking Lot behind the First National Bank and see what the Beautification Committee has done with the plants. He is pleased with what all they have done. Also on Gallatin and Kennedy Blvd, they have put in flower pots and improved the looks of Vandalia. They are also working around the Tourist Information Center to trim the bushes and plant trees this fall.

Mayor Gottman said that he is trying to get a meeting with IDOT to talk about some of the Interchanges to get them mowed down next year.

A motion was made to let the Art group use the Chamber of Commerce building by Barker and seconded by Crawford. Motion carried.

Mayor Gottman said that he was making a trip to Springfield next week to meet with the Legislative's assistants to see what's going on for the next upcoming session in the State Capitol.

<u>CITY ADMINISTRATOR'S</u> REPORT:

LaTisha Paslay said that Marlin Filer wanted her to remind everyone about the road oilings and the Media has been made aware and has published the map.

LaTisha Paslay said that the Homecoming Parade will be Friday September 29, 2017 starting at 2:30pm and it will be taking the same route as last year around the school. No road closure is needed.

CODE OFFICIAL'S REPORT:

The Code Official's Report is in the packet. Mayor Gottman said that the Code Official is working to get 2 houses on 5th Street and 1 house on Rock Island demoed this fall.

Mayor Gottman said that he is impressed with what Zac Kopp is doing.

STANDING COMMITTEE REPORTS:

Dorothy Crawford reported that the Sewer Plant will be sending out for bids for a Stand Pipe on a Pump that has been there since 1986 and that he is taking one of the trucks to Pana to get fixed. The Water Plant has some Pump repairs coming up and he is going to get everything together for the next meeting.

Andy Lester asked about the work on the Tourist Information Center and Mayor Gottman said to get the budget numbers to LaTisha for the next meeting. Mayor Gottman said that him and Andy would look at the front windows at City Hall to get them replaced. Mayor Gottman said that him and Andy would get together for looking at a bid for the Comprehensive Plan.

Mayor Gottman said that there was a letter for the Lake Committee that was drafted by the Lake residents proposal back to us and has been forwarded to our Legal Council in Chicago.

Mayor Gottman said that the Memory Unit has broke ground at the site on Sunset. And there is a new Restaurant that is getting ready to open on Gallatin Street. And we may have another Restaurant open up in the Downtown area that would be an all service restaurant, they will have alcohol but it will not be a bar setting restaurant.

Mayor Gottman said for the Personnel, Finance and Insurance that we will be getting with the Union Reps to look at their Contracts.

Steve Barker with the Tourism Committee reported that they met earlier that day and discussed the Olde Tyme Christmas. Steve wanted to give Donnell Conaway a pat on the back for helping again this year. Steve also wanted to thank True Value (Walt & Paula Barenfanger) for donating lights to light up some trees at the State House during the Olde Tyme Christmas, if approved by the State.

Mayor Gottman stated that if we know of anyone that is a non-for profit Organization, that is wanting to sell goods at the Olde Tyme Christmas, get a hold of LaTisha or Brittany. He also said that Donnell was going to help this year with the characters and then offer to sell us the characters for next year. She is also donating 2 Christmas trees that will be put up on the empty lot and a live Nativity Scene.

Mayor Gottman also wanted to let everyone know that the Vandalia Railroad Museum Foundation was having a fundraiser at McDonalds on Wednesday October 11, 2017 from 5:00-7:00pm, this is the group that is restoring the caboose.

AUDIENCE:

Steve Kerber with Discount Tobacco addressed the Council to have them revisit his request for a liquor license so he can obtain a Class J liquor license which would allow for video gaming. He had applied in November 2016 and the matter died for lack of motion.

Mayor Gottman suggested that he take his application and look it over to make any changes and send it back and then we will have a first reading at the next meeting. And it can be voted on at the first meeting in October.
