**PLEDGE OF ALLEGIANCE:**

The Pledge of Allegiance to the American Flag was given by those present.

**CALL TO ORDER:**

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 7:30 P.M.

**ROLL CALL:**

Aldermen present were: Neil Clark, Beesley, Crawford, Swarm, Hobler and Stunkel. Lester and B. John Clark were absent from the meeting.

**MINUTES:**

A motion was made by Swarm and seconded by Stunkel approving the minutes from the May 20, 2013 as presented. Motion carried.

**REGULAR BILLS:**

A motion was made by Beesley and seconded by Hobler approving the regular bills as presented. Motion carried.

**SPECIAL COUNCIL BILLS:**

A motion was made by N. Clark and seconded by Hobler approving the Special Bills as presented: ADS Electric in the amount of \$2,846.90 to replace ground anchors; Ameren Illinois in the amount of \$2,783.33 for street light; Ennis Paint in the amount of \$2,079.99 for street paint; Southwestern Electric Co. in the amount of \$ 2,000.00 for construction; St. Jacob Winwater Works in the amount of \$4,844.50

for brass couplings; Centraz Industries, Inc. in the amount of \$2,874.00 for sewer solvent; Hurst Rosche Engineering in the amount of \$2,010.00 for the Vandalia Water Treatment Plant Roof Replacement; Brenntag Mid South Inc. in the amount of \$8,8,406.56 for chemical supplies; Motion carried.

Lawler said it was their understanding that the Mabrys' plan to open a business on property that is zoned single family residence. They wondered if the city is ever going to do anything about it.

Lawler commented that we are really counting on the city to stand up for us.

**AUTHORIZATION TO PURCHASE**  
**FOUR AUTOMATED EXTERNAL**  
**DEFIBRILLATORS (A.E.D.'S)**

A motion was made by Swarm and seconded by N. Clark approving the purchase of four automated external defibrillators from DXE Medical Inc. of Brentwood, TN. in the amount of \$5,300.00. Motion carried.

Two of the defibrillators will be purchased with funds from the Old Capitol Foundation and two will be bought with city funds.

Chief of Police Jeff Ray said that they would be placed in squad cars.

**APPROVAL OF PURCHASE OF KUBOTA TRACTOR/MOWER FOR CEMETERY:**

N. Clark reported that the city received three bids for a tractor/mower to be used at the cemetery.

Bluff Equipment submitted a bid of \$18,500.00 for a Kubota tractor and originally offered a trade in of \$2,000 on a 2004 New Holland tractor, but after the Cemetery Committee Meeting found out that the power steering hydraulic went out so the trade-in amount lowered to \$1,000.00 raising the purchase price to \$17,500; John Deere submitted a bid of \$21,130.00; Midwest Tractor Sales submitted a bid of \$19,500.00.

A motion was made by Stunkel and seconded by Beesley to accept the bid from Bluff Equipment. Motion carried.

Hobler questioned why there was no full time secretary at the Police Department.

Mayor Gottman replied by saying there is no money in the budget for a fulltime secretary.

Mayor Gottman said that position was cut in 2010 when we had layoffs at the City.

Mayor Gottman referred this off to the Personnel Committee for review.

**ANNOUNCEMENTS FROM MAYOR GOTTMAN:**

Mayor Gottman announced that he would be meeting Thursday with Byron Sikma about TIF and Enterprise Zone possibilities for South Central FS.

Mayor Gottman told the council that floors have been cut and plumbing will soon be installed at the future Little Caesar's, next to Los Amigos.

Vicki Ellsworth submitted her plans

for the Huddle House and the Embers for review.

Mayor Gottman met with Rick Cripe in regards to the theater. He is still moving forward with that project as soon as the farming is completed.

Mayor Gottman gave a report on the unemployment figures for Fayette County.

Pasley reported on an upcoming event, The National Road Festival that will take place on June 14<sup>th</sup> and 15<sup>th</sup>.

Mayor Gottman talked about the Municipal Opt-Out Electricity Aggregation Bid Results.

Homefield was the low bidder at 0.04433/KWH. The bid allows the city to receive \$.001 KW, since the city will not take any fee the rate will be \$0.04333 that will pass the savings on to the residents.

On Wednesday, June 5<sup>th</sup> from 10:00 a.m. to 12:00 p.m. the Illinois Department of Corrections in partnership with Thoroughbred Retirement Foundation & Illinois Horseman's Benevolent Association presents a "Second Chance Ranch".

This is a program designed to rescue Thorough Horses from slaughter, and provide vocational training in preparation for employment.

Mayor Gottman announced that a Public Hearing will be held prior to the regular council meeting on June 17<sup>th</sup> at 7:00 p.m. for the city's budget for next year.
