I believe our Vandalia Comprehensive Plan will provide solutions to many of the concerns/suggestions listed above in the work that will be done moving forward, guiding economic development, tourism and City administration efforts. I'm currently researching workforce development initiatives that other communities have had success with and hope to collaborate with our local businesses in an effort to help them fill the many positions that currently exist. Whether its at our local manufacturers, distributors, hospital, small businesses, etc. my goal is to help them in whatever way we can to address their/our local workforce deficit. I would say that over 80% of the business owners I met with expressed how difficult it is for them to find good employees, who will show up on time and stay. Not only is there a skills gap that exists, but also lack of soft skills and work ethic. Vandalia ONE efforts will address these issues, but we need something NOW.
