COVID-19-DR. SKOW

A motion was made by Brosman and seconded by Barker approving the minutes from August 3, 2020 meeting as presented. Motion carried.

Dr. Skow, the medical director for the ER at Fayette Co. Hospital expressed his concern with the significant surge of cases recently in the county.

Dr. Skow said that we have the means to curve this right now. We do this by wearing masks and keeping our distance from others. Up until now, we have encouraged the public and businesses to take measures against the virus instead regretting not doing enough when it is too late.

Dr. Skow took questions from the council and Mayor Gottman announced that Dr. Skow along with the Fayette Co. Health Dept. and a nurse will be at the September 8th council meeting to talk more on COVID 19.

Mayor Gottman reported that Fayette County has a total of 80 positive cases reported. The total number tested from the county is now 2,871 with 16 active cases, 62 recoveries and 3 deaths.

A motion was made by Barker and seconded by Hobler Approving Resolution #2020-8-17-A, An Agreement for Grant Management Services Between The City of Vandalia, Illinois and South Central Illinois Regional Planning & Development Commission.

The agreement is with South Central Illinois Regional Planning & Development Commission to provide grant management services for \$550,000 CDBG Public Infrastructure Improvement Grant on a sewer work project.

Mayor Gottman reported on a stabbing that took place early Sunday morning in front of City Hall.

The stabbed victim lives in a downtown apartment. Chief Ray and Mayor Gottman met on the incident. Mayor Gottman said that he plans to talk with Dennis Grubaugh about the incident. This is not acceptable in our town. We have to put a stop to it pretty quick. We've got to screen these people who are coming in, I'm not trying to be mean about it but we had a business that closed downtown because it is too rough downtown. I think it's important that you all are aware of what's going on.

Chief Ray added that the police officers did a good job by making a quick arrest that night. Also, they provided medical assistance to the victim. The EMT's said, that they probably saved the man's life by the medical steps they took. So, Chief Ray wanted to give a shout out to them for that.

Clerk Bowen reminded the council that the next City Council Meeting will be held on Tuesday, September 8th due to Labor Day on Monday, September 7th.

Mayor Gottman reported that he along with Zac Kopp and Russ Stunkel met with a company to look at the trees at the lake and the cemetery. Mayor Gottman said that he should have a proposal by the end of the week. He does not log them. He marks and manages the process.

STANDING COMMITTEES:

Barker reported that the Public Works Committee have been busy fixing water leaks. They also worked on a sewer project today.

The vac truck is being used daily.

Brosman reported that the Water Committee has two requests for adjustments.

No adjustment on the first due to no sewer portion on his bill, so no help on that one.

The second one will have an adjustment.

Brosman thanked the council for approving the retirement of Randy Carroll at the Water Plant. He hopes to have that position filled as soon as possible so we can cut down on the overtime in that department.

Hobler commended the Police Department on the handling of the incident early Sunday morning.

Crawford asked if there was an update on the exterior work going on at the Tourism Center.

Mayor Gottman, no not at this time. He said, that they plan to push that off till next year not knowing what revenues will be coming in.

Mayor Gottman said that it has a new roof on it. We need to weed eat.

Barker said that he didn't think that ramp would last till next year. We did some repairs to it last year and I don't think we can do that again. Barker said, it's going to end up to where if we don't do something before long, we are going to have to shut it down. I don't want to see that happen. Mayor Gottman said, I don't want to see that happen either. Mayor Gottman said that he was just up there and didn't see an issue.

Mayor Gottman suggested that he along with Lester and Andy Vaughan, Building Official meet there on Wednesday.

Barker suggested that we use some of the TIF money to do the repairs. Mayor Gottman said that we will have to take this to the TIF committee and Barker had no problem in doing so. REPORT FROM VANDALIA FIRE DEPARTMENT:

A report from the Vandalia Fire Department for the month of July. Training hours were 160 and they had 6 calls that were none billable.
