Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order via teleconference at 6:30 P.M.

"Pursuant to Executive Order 2020-07, the requirements of 5 ILCS 120.10 directing that a quorum of members of a public body must be physically present for meetings as well as those of 5 ILCS 120/7 limiting the scope of electronic participation in meetings covered by that Act have suspended. The City of Vandalia is following providing the remote participation mechanism for October 5, 2020 City Council Meeting."

motion was made by Hobler seconded by Stunkel Amending Ordinance #2020-10-5-A, Amending 2, Administration Personnel Of The Municipal Code Of Vandalia On Salaries.

The council was in favor of the salary set for the Mayor and the City Clerk but some discussion came up on the salary for aldermen.

Alderwoman Crawford expressed that she felt it would be irresponsible of the council to give themselves a raise at this time. Hobler said it depends on what committee your on. Stunkel said, I don't know how many hours you put in but the lake does enough for two people. Barker expressed that several of the aldermen are putting in a lot of hours in their wards and they have not given themselves a raise in several years.

Crawford said we've got people losing their homes, we've got people losing their jobs we are going to take revenue that is not guaranteed from the state to give ourselves more money. I don't think there is any way we can justify that. What are we going to do come six or maybe eight months from now if we have to lay people off when we just gave ourselves a raise.

Hobler said, we are talking about a 2% raise per year which comes to approximately \$92.00 for the first year which breaks down to \$7.50 a month.

Hobler said, we need to keep the pay up to get qualified people interested in the job as aldermen. Stunkel agreed with Hobler. It's been like 12-15 years since there has been an increase.

Alderman Barker said that if any layoffs were brought up as being needed he would donate his whole salary back to the city and Hobler said, I believe we did that before when the city faced tough situations.

A roll call vote was taken: Hubler, yea; Barker, yea; Stunkel, yea; Rebbe, yea; Hobler, yea; Crawford, nay; Brosman, yea. Motion carried. 6 yea & 1 nay. Lester was absent.

Mayor Gottman reported that the individual has been out to mark the trees at the Cemetery and the Lake. So, he will take the next steps on that situation.

#### STANDING COMMITTEES:

Barker announced that the time capsule has been buried.

Barker commended the Street Department for the good job they are doing.

Stunkel reported that Rob Schukar received a letter from Jon Rinderer Bass Fishing Coach with the McKendree University Bass Fishing Team.

They wished to thank him along with the City of Vandalia for there continued cooperation in allowing the McKendree Bass team to hold both a practice event and the McKendree University Fall invitational on Vandalia Lake.

Stunkel is working with Schukar on the Vandalia Halloween Festival event to be held on October 24<sup>th</sup> at Vandalia Lake.

Stunkel reported that inspections were done on the northside of the lake.

Crawford reminded everyone of the Farmer's market that will take place this Saturday, October 10<sup>th</sup>. Volunteers are needed.

Mayor Gottman noted also in Amber's report is a sign that this company has recommended. Mayor Gottman said that he thought it would be a good idea to have these in windows that are vacant buildings. They could call the city if interested and we can try and get those buildings filled.

On Thursday, October 15<sup>th</sup> at 1:00 pm there will be a ribbon cutting for the new business Kanata Blanket at the former Land O' Lakes/Purina building on Veterans Avenue.

Mayor Gottman did report that at this time we will have our next council meeting on October 19th in person.

We have some items to discuss in Executive Session such as land acquisition and a couple other things to talk about.

We will also have Brian Corrigan with Corrigan-Jones Investing and Nick Meggos our Actuary with Nyhart Services for Police Pension here to talk with the council about the pension. That meeting will be held at 5:30 pm.

Crawford publicly congratulated Mayor Gottman who on September 26<sup>th</sup> became the Illinois Municipal League president. The term is September 2020-September 2021. Congratulations Mayor Gottman.

Brosman said, that he hoped during next year's budget that we could find the money to be able to have the aldermen come up to Chicago and support you as president of the IML.
