### CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order via teleconference at 6:30 P.M.

MEETING BEING CONDUCTED REMOTELY PURSUANT TO EXECUTIVE ORDER 2020-07 SIGNED BY GOV. PRITZKER:

"Pursuant to Executive Order 2020-07, the requirements of 5 ILCS directing that a quorum of members of a public body must be physically present for meetings as well as those of 5 ILCS 120/7 limiting the scope of electronic participation in meetings covered by that Act have suspended. The City of Vandalia is providing the following remote participation mechanism for the 2021 City Council January 18, Meeting."

APPROVE OR REJECT TIF
AGREEMENT EXTENSION REQUEST
FROM VANDALIA CAPITOL, LLC
(DMV & DOLLAR GENERAL)

A motion was made by Brosman and seconded by Barker approving the extension of the TIF Grant for Old Capitol Center.

Amber Daulbaugh, Director of Economic Development received a letter from Brad Bowman, CCIM for First Federal Properties, Inc. giving an update on the progress of the work on the Driver's License Facility & Dollar General.

It was noted that the HVAC units were replaced in September. The flooring in the Driver's License Office was tested for Asbestos and it came back negative. The Kroger floor was also tested and a small area came back positive, but that did not affect the Driver's License office. The flooring was replaced in November.

Bowman stated that the roofing was scheduled to be completed in December. He is planning on having that done the end of January, but it would depend on the weather.

Bowman requested that the TIF agreement be extended till April 4, 2021.

### APPROVE OR REJECT BID FOR DUMP BED FOR CEMETERY TRUCK:

A motion was made by Barker and seconded by Stunkel approving the bid from Higgs Welding, LLC, Dieterich, IL to purchase an 8' Dumper Dog Steel in the amount of \$3,205.00. The city received one other bid from Woody's Municipal Supply Co. in Edwardsville, IL in the amount of \$4,079.00 for a mild steel delivered.

## APPROVE OR REJECT CHANGE ORDER 4A FOR WATERMAIN PROJECT:

A motion was made by Brosman and seconded by Stunkel approving the Change Order 4A for Watermain Project in the amount of a decrease of \$8,409.69 on the Water Main Replacement.

Lee Beckman, Engineer for Milano & Grunloh Engineers stated that this is the change order on the balancing of quantities for the contractor for Section 4A to adjust the contract for the actual work completed except seeding and mulching. The only thing left in the contract besides clean-up is seeding and mulching and addressing any outstanding items.

Brosman remarked that there was a lot of grading done before seeding and with that concern being addressed a vote was taken.

### APPROVE OR REJECT CHANGE ORDER 4B FOR WATERMAIN PROJECT:

A motion was made by Brosman and seconded by Stunkel approving the increase in the Change Order 4B in the amount of \$37,691.29 for the balancing of quantities on work completed on the Water Main Project.

Lee Beckman explained that this is the section on the north end of town. There were some meters that were not known to be attached to the water main replacing so they needed to be added in the contract and one other item, the water main that wasn't connected so that needed to be tied in.

The leveling and grading will have to be done prior to the seeding and mulching.

LEE BECKMAN WITH MILANO & GRUNLOH - UPDATE ON PROJECTS:

Lee Beckman gave an update on the projects taking place in Vandalia.

He did mention the lake study that the Fayette County Soil and Water will update a plan that was previously completed in August 2002 at no charge.

Stunkel mentioned if they did a lake study in 2002 and are willing to do another at no charge I think we do so.

A motion was made by Stunkel and seconded by Brosman allowing the Fayette County Soil & Water to do a lake study at no charge to the city.

MAYOR'S REPORT:

Mayor Gottman said as you all know the city authorized the Fire Department to go out for bid for a new truck. Budgeted figures are a little over \$600,000. The city received one bid that is still sealed and the other company asked for an extension of thirty days.

Fire Chief, Mark Meadows called the company today and they informed him they could not go less than thirty days.

City Attorney, Ryan Connor felt given this type of expenditure, he would recommend more than one bid at any moment in time. He did not recommend going with a single bid.

Brosman expressed his opinion by saying we do not need to be in a rush and agreed with City Attorney Connor's recommendation that we wait for more bids.

A motion was made by Brosman and seconded by Lester to hold off till we receive another bid.

Mayor Gottman stated that the Illinois Department of Public Health has moved us to Pier I of Phase 4 under the Covid-19.

Mayor Gottman also spoke on the policing bill brought before the legislators in lame duck session did pass. IML was able to preserve immunity for the police officers.

Mayor Gottman announced at the February 1<sup>st</sup> City Council Meeting we will have three attorney's in our chamber. We will be meeting in person due to Executive Session.

Mayor Gottman announced that Little Caeser's has closed in Vandalia. They have already removed the inventory inside the building.

### STANDING COMMITTEES:

Barker reported that the Street Department is doing repairs to Sixth Street.

The sidewalk between Seventh and Eighth Street on Edwards Street is almost complete other than seeding and grading.

Brosman said that the Water & Sewer Committee had a very productive meeting.

Brosman wished to welcome our new employee Jeff Elder to the Water Treatment Plant.

Brosman also gave a shout out to the Water Department for keeping this going while we are short staffed and controlling the overtime the best they can.

Chief of Police, Jeff Ray said that he advertised for a part-time tele-communicator.

There being nothing further to discuss, a motion was made by Stunkel and seconded by Hubler to adjourn.
