seconded by Barker authorizing to seek bids for a new Police Vehicle.

This vehicle will be paid with funds from the Police Vehicle & DUI Funds. It will be replacing a 2007 Chevy Impala squad card. Motion carried.

MAYOR'S REPORT:

Mayor Gottman said that he received numerous complaints from residents about the high gas prices in Vandalia as compared to other area cities.

Mayor Gottman said, when you call some of the corporate offices they won't talk with you about it.

Mayor Gottman wanted it publicly known that he has tried to make some contacts and its basically finger pointing.

Let it be known, that the City of Vandalia does not set the prices for gas, they are set by someone else.

Mayor Gottman said that he received an email from Richard Briley in regard to signage at North Eighth St.

Mayor Gottman said that he would refer this to the Chief of Police, Jeff Ray for him to look into it and bring a recommendation back to the council meeting on April 5th.

Mayor Gottman also reported under the Federal Covid Act, the City of Vandalia will receive \$825,794.00 in Covid Relief Funds, which must be used, for the most part, for infrastructure within the city.

Hubler reported that Sam Kerr, Sexton at the Cemetery is getting mowers ready for mowing season to resume.

Stunkel reported that they have removed some of the dead trees and looking forward to opening date at the Vandalia Lake.

Mayor Gottman announced that Farmers' market is set to kick off in May. A meeting is set for next week to discuss some of the activities.

COUNCIL COMMENTS & CONCERNS:

Alderwoman Crawford remarked that Eight Street looks really weird since the Old Hospital and the White House taken down.

Lester praised Code Official, Zac Kopp for his job as code enforcer.

Lester mentioned the purchase of the new fire truck but wanted to bring Fire District. Lester asked if there was any progress on that.

Mayor Gottman said that this is something that the City of Vandalia or the Vandalia Fire Department can get involved in. Steve Stombaugh was going to chair that committee, but at this time Gottman was not sure where things stood.

Barker wanted to let the council know, that LaTisha is seeking information on the Class J liquor license. We will follow up on that as soon as we have more information to bring back to committee.
