Ty Bates of Shelter Insurance is looking to redevelop the building at 730 W. Orchard St. to move his insurance agency to as Bates says they have outgrown their current location.

Bates addressed the council asking for 50% TIF funding for the project but the recommendation of the TIF Advisory Committee for the project was to provide 25% TIF funding.

Alderman Stunkel suggested that the youth groups from different churches help in getting things to the curb for Clean-Up Week who are unable to do so.

Mayor Gottman gave an update on the legislation with the IML.

Mayor Gottman says that one of his big concerns is the reducing of the funds to the municipalities in 2022.

Chief of Police Ray reported that he looked at the intersection in question from the last meeting, Eighth & Orchard but nothing can be done there. Ray spoke with the resident who filed a complaint in that area.

Crawford asked if we had any updates on the Tourism Building. Mayor Gottman said that we are waiting on this year's budget.

Stunkel reported that the lake is open for the season. Stunkel did receive some complaints with area residents driving go carts and three wheelers out at the campground areas of the lake. It was discussed if the city could request the county to patrol at certain times to help shorten the situation.

A Tourism Committee Meeting will be held next week.
