He also reminded council that the IML conference will be held in Vandalia from July 14 through July 17, 2021. The Mayor announced that the Fourth of July fireworks will be held on July 3, 2021. The Halloween Parade hosted by the Lions Club will be held this October. The second Farmer's Market will be Saturday, June 12, 2021 from 8 a.m. until 11:00 a.m.

Huhn reported that the new office hours for the City Clerk's office began June 7, 2021 and that the office is no longer closed during lunch.
