PLEDGE OF ALLEGIANCE:

The Pledge of Allegiance to the American Flag was given by all that were present.

CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 6:30 pm.

ROLL CALL:

Barker, Stunkel, Lester, Hubler, Brosman and Hobler were present. Lewey and Rebbe were absent.

MOMENT OF SILENCE:

A moment of silence was observed for Mrs. Mary Miller, a local business owner.

MINUTES:

A motion was made by Stunkel and seconded by Hobler approving the minutes from the September 20, 2021 meeting as presented. Motion carried.

TREASURER'S REPORT:

The general sales tax revenue, infrastructure sales tax revenues, gaming revenues, telecommunications tax revenues, cannabis use tax, income tax revenues, use tax revenues, motor fuel tax revenues and hotel/motel tax revenue reports were reviewed. No action needed.

REGULAR BILLS:

A motion was made by Stunkel and seconded by Barker approving the regular bills as presented. Motion carried.

SPECIAL BILLS:

A motion was made by Stunkel and seconded by Hobler approving the special bills as presented: SCIRP&DC in the amount of \$1,892.00 for membership dues; Arrow Valley Landscaping in the amount of

UNFINISHED BUSINESS:

Gottman reported on followup items from the September 7, 2021 City Council meeting: Ordinance 2021-9-7-G: Ordinance of Vacation - Unimproved Locust Street: The City has not been able to make contact with the property owner. Regarding downtown grants offered by the State of Illinois, Paslay and Gottman will see what grants the City is eligible for. A copy of the Aldermanic-City form of government section found in the IML Handbook was reviewed.

### MAYOR'S REPORT:

Gottman reported the City is holding an Employee Appreciation cookout on Friday, October 22 from 11 a.m. until 1 p.m. at Charters Patio. All City employees and aldermen are invited. Gottman congratulated the High School Boys Golf Team who tied for 2<sup>nd</sup> at Sectionals and are moving on to State. Chase Laack, stepson of Council member Joel Rebbe, placed first at sectionals. He also noted that the 7th grade VYO football team went undefeated this season. Gottman reported on the IML Annual Conference in Chicago. He said it was a very successful conference. Brosman commented that at one of the seminars he attended a topic of discussion included the amount of money being made in cannabis. Gottman reported that the Council has approved any cannabis ordinances and would approve the businesses under a special use permit. Gottman noted that the City made \$5,755.00 in cannabis use tax last year and so far this year, has made \$4,182.00 from the sales of products such as CBD oils.

## CITY ADMINISTRATOR'S REPORT:

Paslay reported that the last Farmer's Market is Saturday, October 9, 2021. In addition, the Grand Levee, Atlas 46 Grand Opening, Vandalia Fire Department's Golf Scramble, Vandalia All School Reunion Banquet and Vandalia High School Homecoming will also be on October 9.

### STANDING COMMITTEES:

Barker reported the Street Department has been busy working on leaks. Chief Ray reported that the Vandalia Homecoming Parade is Thursday, October 7 at 5 p.m. The parade route will be the same as it was in the past. Stunkel reported that students from 39 different colleges were at the Lake over the past weekend. Recommendation was made to restock the Lake. The High School Art class will be painting murals on some of the buildings at the Lake next Spring. Hubler stated that he would like to see a full time Tourism Director hired. Gottman referred the matter to Public Safety Committee.
