## City Council Regular Meeting

November 1, 2021 6:30 pm

PLEDGE OF ALLEGIANCE:

The Pledge of Allegiance to the American Flag was given by all that were present.

CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 6:30 pm.

ROLL CALL:

Stunkel, Lester, Hubler, Brosman, Hobler, Lewey and Rebbe were present. Barker arrived at 6:32 p.m.

MOMENT OF SILENCE:

A moment of silence was observed for Mr. Rick Nalley, a local business owner.

MINUTES:

#### MAYOR'S REPORT:

Gottman reported that downtown Trick or Treat was a big success. Olde Tyme Christmas is scheduled for November 12 and 13 in downtown Vandalia. Gottman reminded council members to shop local this holiday season. Harry's 66 Liquor has made improvements to their building. He also reported that on Tuesday, November 2, the Looking for Lincoln Project committee will be planting a tree at the State House in honor of Mary Truitt. Gottman noted that a bill requiring additional reporting on TIF has been approved by the Illinois House and Senate and is on the Governor's desk. He also reported that the bill to increase video gaming terminal fees has also passed the House and Senate and is on the Governor's desk. He reminded Council that the high school boys football team will play in the playoffs on Saturday, November 6. He also reviewed the Economic Development report provided by Amber Daulbaugh, Economic Development Director, highlighting the Small Business Saturday Coupon Tear Off promotion.

#### CITY CLERK'S REPORT:

Huhn reported that she attended a week long Municipal Clerks
Conference. She also stated that she is working on a project that, in the spirit of giving and the holiday season, will allow the opportunity for people to gift payment of another person's water bill during the holiday season. If this is a success, consideration is being given to making this a permanent program.

## CITY ADMINISTRATOR'S REPORT:

Paslay reported on lake lot leases. As of November 1, 72 have opted to buy, 25 are opting for the new lease, and 5 have opted to remain with the current agreement. She has also received 16 appraisals.
