Letters were sent to those owners addressing those issues. The CEO Class is presenting a Murder Mystery event on January 16, 2022 from 2 p.m. until 5 p.m. The City has purchased a table of 8. If interested in participating, let Carla know as soon as possible. A Train Show has been scheduled for January 29, 2022 from 10:30 a.m. until 3:30 p.m. at the Moose Lodge. Proceeds will be used to help restore the Red Caboose. Union negotiations will begin shortly. Gottman reported that he has talked with one union representative. Gottman will contact them to see when they will be ready to begin negotiations. Police, Dispatchers and Laborers contracts will be negotiated.
