CALL TO ORDER:

Mayor Gottman called the regularly scheduled meeting of the Vandalia City Council to order at 6:30 pm.

Ben Frazier, CEO of Family YMCA of Fayette County, thanked all of those who came to the meeting in a show of support for the Y. A motion was made by Brosman and seconded by Barker to approve Resolution 2022-4-4-A: A Resolution in Support of the Family YMCA OF Fayette County.

ORDINANCE 2022-4-4-B: AN ORDINANCE OF THE CITY OF VANDALIA, FAYETTE COUNTY, ILLINOIS, AUTHORIZING TAX INCREMENT FINANCING ASSISTANCE IN CONNECTION WITH A REDEVELOPMENT PROJECT - HOHLT AND FILE FUNERAL HOME - \$15,090 (25%):

Sue Kistler, owner of Hohlt and File Funeral Home, reviewed her TIF request. TIF Advisory Committee recommended 25% approval of the total project cost (\$60,360.00) which would be \$15,090.00. She did state the ordinance read "building purchase and renovation" but the request is for improvements only as she owns the building. Paslay will make that change. Brosman stated referring to the best practices agreement and the goal of TIF, he looks for an increase in EAV and an increase in jobs, which he did not see in this request. He did not think TIF would be the appropriate mechanism. He stated the City has an annual sidewalk replacement program that might better suit this project.

Motion was made by Stunkel and seconded by Hobler to approve Ordinance 2022-4-4-B: An Ordinance of the City of Vandalia, Illinois, Fayette County, Illinois, Authorizing Tax Increment Financing Assistance in Connection with a Redevelopment Project - Hohlt and File Funeral Home - \$15,090 (25%).

ORDINANCE 2022-4-4-C: AN ORDINANCE OF THE CITY OF VANDALIA, FAYETTE COUNTY, ILLINOIS, AUTHORIZING TAK INCREMENT FINANCING

Haley Tompkins and Ty Bates of Capitol View Properties, LLC, reviewed their TIF request with the council. The lower level of the building will house Tompkins' current business and possibly add ASSISTANCE IN CONNECTION WITH A REDEVELOPMENT PROJECT - HALEY BOLEY TOMPKINS AND TY BATES -\$50,869.73 (25%):

another business. The current building that Tompkins rents for her business will not be left vacant as there are a couple of businesses who could possibly move into that space. The second and third levels will house Air BNBs. Taxes on the building are currently assessed at \$300.00 a year but estimated the building with the renovations will be reassessed at approximately \$4,500.00. Brosman stated using the best practices agreement, he is against using TIF funds for the acquisition of real estate. He does not consider this property derelict. He does not see a great increase in sales tax revenue. However, he is supportive of the increase in the EAV. TIF Advisory Committee recommended 25% approval of the total project cost including the acquisition which would total \$50,869.73. Motion was made by Hubler and seconded by Stunkel to approve Ordinance 2022-4-4-C: An Ordinance of the City of Vandalia, Fayette County, Illinois, Authorizing Tax Increment Financing Assistance in Connection with a Redevelopment Project - Haley Boley Tompkins and Ty Bates - \$50,869.73 (25%)

ORDINANCE 2022-4-4-D: AN ORDINANCE PERTAINING TO THE REGULATION OF VIDEO GAMING FOR THE CITY OF VANDALIA, ILLINOIS:

Ordinance that was passed at the March 21, 2022 meeting was revised. One provision was revised and one was eliminated. The City is no longer requiring information related to gross revenue and how it breaks down with gaming versus nongaming. Also, the City will no longer require computer generated images of

the entirety of the layout of the floor plan. The City will require floor plans of the designated gaming area only. Applicants will not have to submit a high resolution computer generated floor plan. A motion was made by Brosman and seconded by Hubler to approve Ordinance 2022-4-4-D: An Ordinance Pertaining to the Regulation of Video Gaming for the City of Vandalia, Illinois.

the Governor's staff at Lobby Day last week in Springfield. He stated he was not in favor of raising property taxes, and noted that the gaming revenue taxes help fund the Police Pension fund. He also stated that the tree on the corner of Coles and Randolph Streets will be removed for safety reasons as soon as possible at the direction of Gottman. The City has also asked the homeowner to clean up the property at Coles and Randolph Streets and the City will be monitoring that property.
