UNFINISHED BUSINESS/ ENGINEER'S REPORT:

Lee Beckman from Milano & Grunloh was present and reviewed the June 2022 Engineer Update. Octochem Water Main Project will be completed this week. Preconstruction meeting for Octochem Street Project is scheduled for June 28, 2022 at 12 Noon at City Hall. Fillmore to Washington Streets water main project will begin next week. Main Street lift station is ready to go to the EPA. The City needs a piece of property, and once that property is acquired, the project can proceed. Lake Dam — waiting for the water at the Lake to

go down so it can be surveyed and then project can be bid out. Safe Routes to School - project can be bid out once the remaining properties are secured. The church is waiting on an appraisal and Paslay is working with the remaining two property owners. Grant was not funded for the watermain replacement on Main Street. DCEO changed the grant amount to \$1,500,000 so the City will reapply for a new area. Beckman is working with Marlin Filer on this. ITEP is moving forward. This will be bid out with construction planned for next spring. The City was awarded a grant in the amount of \$60,000.00 for upgrades at the sewer plant.

MAYOR'S REPORT:

Mayor Gottman reported that he had the opportunity to meet Jackie Joyner-Kersee who was in Vandalia as a guest speaker at an FNB Community Bank employee event. IDPH performed an inspection at the Lake, and all citations have been resolved except for one. Paslay is working with Rob Schukar, Lake Manager, to remedy this. Gottman reminded the Council the importance of shopping local. He noted a couple of restaurants have closed recently, and he has been in contact with those owners. Wal-Mart notified Gottman that the side street between the retail center and Wal-Mart will be closed for 2 to 3 weeks beginning today.

STANDING COMMITTEES:

Steve Barker reported Street Department will be busy picking up limbs and trees due to Friday's storm. Andy Vaughan will put together a bid spec to replace an old building at the cemetery. Lester stated that he will be getting bids for painting the upper face on the north and east sides of City Hall, which is starting to peel. Stunkel reported the Lake Committee will need to meet to discuss rentals at the Lake. Paslay will work with Stunkel on getting that meeting scheduled. The new sign at the Lake blew away recently. Hubler reported that the Grand Levee was last weekend. Gottman thanked the City workers for their help in putting up the tent and also putting the flags around the State House. Lewey reported one new employee has been hired at the water plant and Paslay reported that she is advertising for one more open position at the water plant.
