Motion was made by Stunkel and seconded by Hobler to approve the transfer of Lake Lot 602 from David Huffman, House Springs, MO to Danny and Margaret Lallish, Ramsey Illinois. There were no objections. Motion carried.

WATER AND SEWER RATE DISCUSSION:

Motion was made by Brosman and seconded by Stunkel to recommend 0% rate increase on the sewer rates and 2.94% increase in the water rates effective October 1, 2022. There were no objections. Motion carried.

UNFINISHED BUSINESS:

Lee Beckman of Milano and Grunloh
Engineers updated Council on ongoing
City projects. Great progress has
been made on the Fillmore to
Washington project. Randolph Street
project will be bid out first
quarter of next year. Main Street
Lift Station - Beckman will meet
with Paslay regarding bid opening.
Michel's Feed Store sidewalk project
should be completed this fall. Lake

Dam project - Beckman talked to JB Eskers who would be comfortable doing work 6 to 12 inches in the water meaning sandbags which would be cost effective from a financial standpoint. Beckman didn't know if this would get the water level down low enough that repairs could be made. He is going to continue to look into that. Question was raised about using rip rap instead of poured concrete panels. Stunkel said he met with somebody who owns a barge that has a conveyor that places the rip rap exactly where it needs to go. Beckman said the biggest concern with that is he doesn't think the slope would facilitate for the rip rap to stay in place. Safe Routes to School will make the November letting. Construction will begin next Spring. Gottman asked for a written report on the breakdown of Safe Routes to School. Beckman reported the water treatment project is moving forward. Stunkel asked about bridges. The City will complete a bridge survey in 2023. Gottman asked the Streets Committee to meet regarding bridges, in light of the infrastructure bill that was passed in Washington DC regarding grants.

MAYOR'S REPORT:

Gottman reported that he and Paslay attended the IML Conference in Chicago last week. He did talk to both candidates for Governor as far as concerns related to Vandalia. The new lights on Fourth Street are installed (the four closest to the bridge, 2 on each side). He talked with the company that the City bought the lights from and he said the light poles are too far apart. He recommended putting 2 light posts at each intersection. Gottman noted that Dennis Grubaugh did get the

house on Gallatin Street demolished. It is all seeded and strawed.

CITY CLERK REPORT:

CITY ADMINISTRATOR REPORT:

STANDING COMMITTEES REPORTS:

Barker reported the Street Department is oiling the streets. Lester stated that he will have a quote for painting the exterior of the north side of City Hall. Stunkel reported the next Lake meeting is October 3. Stunkel reported the dam at the Route 185 bridge over the lake is starting to have some cracks in it. IDOT will need to send somebody over to look at it. Lake will close the middle of October. Huhn reported on Festival of Lights. Hubler reported on the mustang show that was in town over the weekend, and noted participants shopped local businesses. Hubler asked about golf carts and how the Aldermen felt about that. Effingham just passed an ordinance allowing golf carts. Todd Stapleton from the radio station will conduct a poll on the radio's website. Gottman stated this should go to the Public Safety Committee. Also discussion will be held regarding motorized bicycles at that meeting. Hubler went to Brownstown Cool Down and said he would like to see the City hold a festival similar to that. Wine and Ale with Abe is this weekend. Andy Gelsinger has interviewed 4 people and he has been authorized to proceed with hiring.
